

## **User Agreement/Waiver**

## By being permitted access to Penn Campus Recreation Facilities, users acknowledge their agreement to the following:

- 1. Certain risks of injury are inherent to participation in sport and recreational activities including both group exercise and instructional These types of injuries may be minor or serious and may result from one's own actions, of others', or a combination of both.
- 2. Posted or distributed rules and regulations are designed for the safety and protection of recreational users, who in turn are responsible to abide by these rules and Failure to comply will result in membership restrictions.
- 3. Penn Campus Recreation reserves the right to shut down/deny access to any or all of its facilities for preventative maintenance or emergency repairs. Operating hours may change permanently or temporarily during the course of your membership if deemed necessary by management for operational, emergency, or weather related reasons.
- 4. A valid Penn ID, activated with a current Penn Campus Recreation membership, is required to access all Penn Campus Recreation Facilities. Failure to comply will result in denied access.
- 5. Certain activities require a minimum level of health and fitness ability. Recreational users warrant being physically fit to use facilities and participate in any activities undertaken, and understand a choice to participate brings with it the voluntary assumption of risks of injury or illness (including the risk of contracting communicable disease), which may arise from participation in these activities and/or use of recreational facilities.
- 6. Recreational users agree that the University of Pennsylvania, its employees, and agents shall not be liable for personal injury or damages to personal property arising from, or in any way resulting from the use of facilities and/or users' participation in activities, and agree to waive such claims, including claims for negligence, against the University for such injury or loss.
- 7. Release, waive, discharge, and agree to hold harmless the Trustees of the University of Pennsylvania and all its successors, assigns, affiliates, officers, directors, employees, students, and agents from all actions and causes of action, suits, debts, accounts, judgments, claims and demands whatsoever in law or equity, and attorney's fees, including all claims arising out of any incidents involving personal injury in any way by reason of Penn Campus Recreation membership and/or use of Penn Campus Recreation facilities.



- 8. I consent to the use of my name, portrait, picture, photograph or video as part of the University of Pennsylvania Campus Recreation Department. I hereby give Penn, its employees, agents, successors, assigns and those acting with its permission or on its behalf, the right and permission to use, copyright, publish, republish and distribute any such recording, video or photographs of me. I understand that any such recording, video or photographs belong to Penn and that I will not receive any payment or other compensation in connection with such recording, video or photographs or for any use of them by Penn. I agree that Penn may use such recording, video or photographs, in whole or in part, in any manner and in any media, including in composite, altered, or distorted form. I waive any right that I may have to inspect or approve the finished products or materials containing my likeness and/or voice, or the printed matter that may be used in connection with such recording, video or photographs.
- 9. <u>Age Requirements:</u> Members and guests must be 18 years of age or older to access fitness areas and weight Dependent members/guests under 18 years of age must enter the facility with an adult/guardian who must also remain in the facility while it is being used by the dependent. Individuals under 18 years of age are prohibited from weight rooms, fitness areas, classes, and sauna. A Members and guests 16 years of age and under must be directly supervised by an adult or guardian at all times. Children 4 years of age and older are not permitted in opposite sex locker rooms. Single person changing rooms are available in both facilities.
- 10. I have read and acknowledged the Campus Recreation cancellation policy. I understand that all membership cancellations are subject to certain provisions found on the Membership Cancellation Policies website. By my signature below, I agree to the User Agreement/Waiver, Payroll Deduction procedure, Installment Plan Procedure, and/or that my payment will be processed at the time of registration.
- 11. If you sponsor a spouse or dependent, you are liable to provide payment in the case that the spouse or dependent does not or cannot provide payment for their membership or any programs/products purchased from Penn Recreation.

I acknowledge that by signing below, I am agreeing to and accepting the waiver/assumption of risk associated with the selected membership/ program for myself or as the parent or legal guardian of the minor registrant.
